Estimated Period: In the event no meter read is provided by the TDSP at the time your invoice is issued, we may issue you an invoice based on your estimated usage for the invoicing period. This period will be identified on your invoice as an "Estimated Period" and will be adjusted accordingly once actual meter reads are provided.

If, after contacting Infinite Energy first, you are not completely satisfied with our findings, you have the right to file a complaint with the PUCT. You may contact the PUCT locally by calling (512) 936-7120, or toll free in Texas at (888) 782-8477. You may also contact the PUCT by mail—see below for the address. Hearing and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136.

Conditional Payments: Any form of payment you send to Infinite Energy for less than the full balance due, which is marked paid in full or is tendered as full satisfaction of the balance, may be treated, in Infinite Energy's sole discretion, as (a) a partial payment on your account or (b) improper payment and refused by Infinite Energy by either returning it to You, not cashing it, or destroying it. 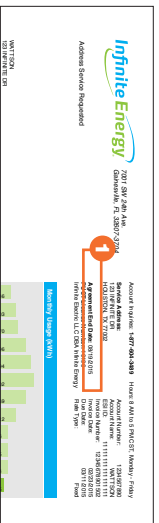

1 Agreement End Date

Your current rate plan will be in effect until this date.

2 Actual Charges

This column shows a running tally of your actual electricity charges and previous payments. We recalculate your budget billing four times each year to make sure it is aligned with your actual charges.

3 Budget Charges

This column shows your current level billing charges, also called budget billing charges. The total shown here is the amount due.

4 Average Price per kWh

Your average price is calculated as the sum of your energy charges, recurring TDU charges and service fees, divided by your consumption and rounded to the nearest one-tenth of a cent.

5 Remittance Slip

Please include your customer number on your payment. This helps us quickly credit your account even if your payment should be separated from the payment coupon during processing.

6 Energy Charge

A charge based on the electric energy (kWh) consumed.

TDU Delivery Charges

A charge to cover the cost of moving electricity from the generation plant to your home.

Service Fee
Administrative fee.

Miscellaneous Gross Receipts Tax Reimbursement

A fee assessed to recover the miscellaneous gross receipts tax imposed on retail electric providers operating in an incorporated city or town having a population of more than 1,000 people.

PUC Assessment

A fee assessed to recover the statutory fee for administering the Public Utility Regulatory Act.

Sales Tax

Sales tax collected by authorized taxing authorities, such as the state, cities and special purpose districts.
